2020 Health & Safety Policies

GDDA Class Safety Policies:

- ~ Dancers/Teachers are asked to **stay distanced at least 6ft apart**. Spaces for the dancers will be taped on the floor.
- ~ **Small class sizes:** approximately 6-12 dancers upstairs and 4-7 downstairs. Some classes will be held outside on **deck** as often as weather permits.
- ~ Parents will check in child at the studio door then leave (parents do not enter building). One parent is permitted to walk with young child to their class then leave (please wear mask). **Our waiting room is closed.** Parents are welcome to wait on outdoor seating or in their car. Parents can visit office during office hours (one parent at a time, please wear a mask).
- ~ Dancers/Teachers **sanitize hands** as they enter and exit the building & between classes.
- ~ Spots will be assigned for dancers' belongings in the studio. Bring small dance bag with only necessary items that will all fit in bag: shoes, water bottle with name on it, mask, etc.
- ~ **Masks** are recommended when in the building for all dancers/teachers who are able to wear them. When dancing outdoors, masks are not recommended but are optional.
- ~ Front & back building doors will stay open as much as possible for extra ventilation in studio.
- ~ Dancers should use home bathroom before coming to studio. Only use studio bathroom if absolutely necessary and spray with disinfectant spray after use (provided by GDDA). If your child is young and needs assistance in bathroom, please stay in parking lot so you can be called to help if needed.
- ~ Staff will **clean** studio floors and any touched surfaces between every class.
- ~ No close contact/partnering will be done in class. No use of gym mats or shared props.
- ~ Dancers/Teachers must not come to class if they have any signs of illness or any family member with signs of illness or have had any exposure in the past 20 days to someone with COVID. Please check temperature at home before attending GDDA class.
- ~ Dancers/Teachers are asked to follow state travel guidelines. If you have recently traveled to a state with high COVID cases, please quarantine for 14 days before attending GDDA classes.
- ~ If a dancer needs to quarantine, isn't feeling well, or doesn't feel comfortable coming for any reason, classes can be live-streamed through Zoom upon request.
